#### APPROVAL OF MINUTES

#### DANGEROUS STRUCTURE HEARING

The dangerous structure hearing for 1516 Hickory Street was held. Mike Norman, the owner of the property, appeared before the governing body explaining he has secured the structure and is continuing to clean up the trash and inoperable vehicles. Mayor Kieser told him to continue cleaning the property. Norman has 30 days to get rid of the inoperable vehicles.

#### VISITORS

Nate Daniels thanked everyone for their support during the weekend fire. Daniels said Chief Whetstine is instrumental in answering medical calls. Daniels thanked the City for making employees available to answer emergency calls.

Nate Daniels informed the City he is trapping cats, but getting lots of possums and racoons. He is relocating the possums and racoons, but the clean up after is time consuming. Daniels reminded the governing body cats can only be held in the cages for 4 hours with no food and water. A cost assessment will be completed on the cat trapping. Megan Shackelford asked if the City can trap the cats at Elwood Park, the former Sunflower Village. Since it's private property, the owner needs to make the request.

### CHIEF OF POLICE

Chief Whetstine informed the governing body the Durango is back in the shop with an antifreeze leak.
